Some months before the Juneteenth opening of our latest museum: MUSEUM OF AFRICAN AND AFRICAN AMERICAN ART, HISTORY AND CULTURE, I was hoping that the very dangerous non-ADA compliant city sidewalk in front of the museum would be replaced with a ADA stamped red brick sidewalk like the one recently constructed on the south side of the old Texan Cafe, and that a set of safe died concrete steps across Main Street could be constructed to replace the current dangerous steps so that visitors parking in the Museum of Texas furniture lot would have easy access to the museum unless handicapped in which case they would need to park in front of 1428 Main Street and use a new ADA compliant sidewalk to access the museum.

Covid 19 put a hickey into those plans but the city is back at constructing new sidewalks, even replacing some that meet ADA specs.

Therefore I cannot find an excuse for not meeting with me (with masks on of course) to plan the sidewalk so that my handicapped wife can someday visit the museum that she half paid of the costs of purchase of the building and the contents.

I believe that even "Lying Leonard" might stoop from his high horse to inform you that the city is knowingly allowing a non-ADA compliant sidewalk to endanger citizens without disabilities but also to prevent handicapped citizens from using the dangerous sidewalk at. The liability issue does not paint a pretty picture for the taxpayers.

Please communicate with me ASAP so that we can work to design a beautiful and appropriate sidewalk.

The only practical egress is via either one or two driveway entrances in front of two other museums and then north on the ADA friendly sidewalk I built to replace the damaged sidewalk that was unsafe. Heading north At the end of the section I replaced begins the section that the city said they would replace and make ADA compliant and safe at least two years ago. It is quite dangerous and the new ADA sidewalk will need a hand rail on the east side as the sidewalk is bounded by a steep slope down to the street. It will need to go all the way to the corner of University Ave and 14th Street where it meets two sets of concrete stairs.

The City of Huntsville, its Mayor, Council and City Manager obviously believe that the ADA does not apply to them and is a joke. At the last City Council Meeting I attempted to once again complain not only about the dangerous sidewalk in front of our Museum of African and African American Art, History and Culture, but also about many non-ADA complaint dangerous sidewalks in Huntsville.

The only practical egress is via either one or two driveway entrances in front of two other museums and then north on the ADA friendly sidewalk I built to replace the damaged sidewalk that was unsafe. Heading north At the end of the section I replaced begins the section that the city said they would replace and make ADA compliant and safe at least two years ago. It is quite dangerous and the new ADA sidewalk will need a hand rail on the east side as the sidewalk is bounded by a steep slope down to the street. It will need to go all the way to the corner of University Ave and 14th Street where it meets two sets of concrete stairs.

## USES OF PERSONAL INFORMATION

### NOTICE OF COMPLAINANT/INTERVIEWEE RIGHTS AND PRIVILEGES

Complainants and individuals who cooperate in an investigation, proceeding or hearing conducted by Federal Highway Administration (FHWA) are afforded certain rights and protections. This brief description will provide you with an overview of these rights and protections.

A Respondent may not force its employees to be represented by Respondent's counsel, nor may it intimidate, threaten, coerce or discriminate against any employee who refuses to reveal to Respondent the content of an interview. An employee does, however, have the right to representation during an interview with FHWA. The representative may be Respondent's counsel, the employee's private counsel, or anyone else the interviewee authorizes to be present.

The laws and regulations which govern FHWA's compliance and enforcement authority provide that no Respondent or other person shall intimidate, threaten, coerce or discriminate against any individual because he/she has made a complaint, testified, assisted or participated in any manner in an investigation, proceeding, or hearing conducted under FHWA's jurisdiction, or has asserted rights protected by statutes DOJ enforces.

## 42 U.S. Code § 12188 - Enforcement

U.S. Code    Notes

**(a) IN GENERAL****(1) AVAILABILITY OF REMEDIES AND PROCEDURES**

The remedies and procedures set forth in section 2000a-3(a) of this title are the remedies and procedures this subchapter provides to any person who is being subjected to discrimination on the basis of disability in violation of this subchapter or who has reasonable grounds for believing that such person is about to be subjected to discrimination in violation of section 12183 of this title. Nothing in this section shall require a person with a disability to engage in a futile gesture if such person has actual notice that a person or organization covered by this subchapter does not intend to comply with its provisions.

**(2) INJUNCTIVE RELIEF**



In the case of violations of sections 12182(b)(2)(A)(iv) and section <sup>[1]</sup> 12183(a) of this title, injunctive relief shall include an order to alter facilities to make such facilities readily accessible to and usable by individuals with disabilities to the extent required by this subchapter. Where appropriate, injunctive relief shall also include requiring the provision of an auxiliary aid or service, modification of a policy, or provision of alternative methods, to the extent required by this subchapter.

## **(b) ENFORCEMENT BY ATTORNEY GENERAL**

### **(1) DENIAL OF RIGHTS**

#### **(A) Duty to investigate**

##### **(i) In general**

The Attorney General shall investigate alleged violations of this subchapter, and shall undertake periodic reviews of compliance of covered entities under this subchapter.

##### **(ii) Attorney General certification**

On the application of a State or local government, the Attorney General may, in consultation with the Architectural and Transportation Barriers Compliance Board, and after prior notice and a public hearing at which persons, including individuals with disabilities, are provided an opportunity to testify against such certification, certify that a State law or local building code or similar ordinance that establishes accessibility requirements meets or exceeds the minimum requirements of this chapter for the accessibility and usability of covered facilities under this subchapter. At any enforcement proceeding under this section, such certification by the Attorney General shall be rebuttable evidence that such State law or local ordinance does meet or exceed the minimum requirements of this chapter.

#### **(B) Potential violation**

If the Attorney General has reasonable cause to believe that—

**(i)** any person or group of persons is engaged in a pattern or practice of discrimination under this subchapter; or

**(ii)** any person or group of persons has been discriminated against under this subchapter and such discrimination raises an issue of general public importance,

the Attorney General may commence a civil action in any appropriate United States district court.

## **(2) AUTHORITY OF COURT**

In a civil action under paragraph (1)(B), the court—

**(A)** may grant any equitable relief that such court considers to be appropriate, including, to the extent required by this subchapter—

- (i)** granting temporary, preliminary, or permanent relief;
- (ii)** providing an auxiliary aid or service, modification of policy, practice, or procedure, or alternative method; and
- (iii)** making facilities readily accessible to and usable by individuals with disabilities;

**(B)** may award such other relief as the court considers to be appropriate, including monetary damages to persons aggrieved when requested by the Attorney General; and

**(C)** may, to vindicate the public interest, assess a civil penalty against the entity in an amount—

- (i)** not exceeding \$50,000 for a first violation; and
- (ii)** not exceeding \$100,000 for any subsequent violation.

## **(3) SINGLE VIOLATION**

For purposes of paragraph (2)(C), in determining whether a first or subsequent violation has occurred, a determination in a single action, by judgment or settlement, that the covered entity has engaged in more than one discriminatory act shall be counted as a single violation.

## **(4) PUNITIVE DAMAGES**

For purposes of subsection (b)(2)(B), the term “monetary damages” and “such other relief” does not include punitive damages.

## **(5) JUDICIAL CONSIDERATION**

In a civil action under paragraph (1)(B), the court, when considering what amount of civil penalty, if any, is appropriate, shall give consideration to any good faith effort or attempt to comply with this chapter by the entity. In evaluating good faith, the court shall consider, among other factors it deems



relevant, whether the entity could have reasonably anticipated the need for an appropriate type of auxiliary aid needed to accommodate the unique needs of a particular individual with a [disability](#).
